**As compensation to “the Fair” for providing “the Vendor” with a 10x10 space during the specified event(s), “the Vendor” agrees to pay \$75.00 Fee due when the contract is turned in, prior to the event on September 6<sup>th</sup>, 2014.**

***All Vendors/Crafters are subject to approval.***

Vendor agrees to indemnify and hold harmless The Market at DelVal, Shady Brook at Fleming’s, Inc. and Delaware Valley College, its employees, officers and directors from any damages, actions, suits, claims, or other costs arising out of our in connection with any damage to any property or any injury caused to any person or persons by “the Vendor” during their use of the space, including any acts or omissions on the part of “the Vendor”, its guests, employees, officers, directors or other agents. “The Vendor” shall notify “the Fair” of any damage or injury of which it has knowledge in, to, or near the space, regardless of the cause of such damage or injury.
